Offer to Lease Mineral Interest in Fisher County, Texas

Ms. Marstaller introduced Mr. Roane Lacy. Mr. Lacy reviewed information on the Evangelina Settlement which EOAC is a beneficiary from the Charles Hamilton Estate, 7.35294118 acres. The beneficiaries of the settlement include Waco Human Society, First Presbyterian Church, EOAC, St. Paul's Episcopal Church, Central United

Methodist Church. EOAC has received three offers for the mineral rights on the acreage. The offers are from; Equitas Energy Partners and Eagle Permian Partners, LLC, Tango Lima, L.P. and Akolla Resources, LLC.

Motion was made by Ms. Copeland to accept the offer made by Equitas Energy Partners and Eagle Permian Partners, LLC as presented, contingent upon the decision that St. Paul's Episcopal Church and First Presbyterian Church, accept the same offer. Approve Interest Rate and Term of Loan
