## **Results of Most Recent Federal Monitoring Review**

The Administration for Children and Families (ACF) conducted a Focus Area Two (FA2) monitoring review of EOAC Head Start and Early Head Start From January 9 -13, 2023.

**Area of Concern:** Supporting teachers in promoting school readiness AOC 1302.91(e)(1) The grant recipient ensures teachers are prepared to implement the curriculum and support children's progress toward school readiness, but improvement is needed.

**Monitoring Feedback:** A review of the teacher qualification tracking form found the grant recipient identified 15 of 36 Early Head Start center-based teachers who did not have a Child Development Associate (CDA) or comparable credential. These teachers, hired between June and November 2022, each had a professional development plan (PDP) outlining a path to a CDA. The site managers monitored the PDPs.

Timeframe for correction: Follow up with the Regional Office for support.

**Grantee Follow-Up:** Due to the challenge of finding candidates with an infant/toddler CDA, the Policy Council and Board approved a professional development policy that allows EHS new hires six months to achieve an infant/toddler CDA. Most of the staff identified in the monitoring report completed the CDA within the 6-month timeline or resigned. The program will continue searching for a way to secure candidates with an infant/toddler CDA at the point of hire.

**Area of non-compliance:** Budget Planning and Development 642(d)(2)(A)-(I) The grant recipient does not develop and implement its budget to sustain management, staffing structures, and the delivery of services that support the needs of enrolled children and families.

**Monitoring Feedback:** The grant recipient did not share accurate and regular financial information with the policy council.

The frame for correction is 120 days.

**Grantee Follow-Up**: The program shares monthly credit card information, funding applications, and amendments for review and approval. However, the program did not share monthly budget reports. The core cause can be attributed to having new staff in key positions. A Corrective Action Plan was prepared, and steps were outlined to correct this issue. The corrective action plan was submitted, approved, and implemented.

**ACF Office of Head Start Follow-Up:** EOAC received a Performance summary Report on 08.17.2023 as legal notice that the Non-Compliance was corrected.

## Curriculum



EOAC Head Start utilizes Frog Street Pre-K, Frog Street for Twos, and Frog Street Infant Curriculum. Frog Street Love and Learn is used in the Home-Based program. Curriculum supplements include I Am Moving I Am Learning (IMIL), CLI Engage, Creative Curriculum, More than Mudpies, and Choosy Kids. Conscious Discipline, included in the Frog Street curriculum, is a comprehensive classroom management system that

creates a learning environment where children feel safe and loved. EOAC Head Start staff use this system to support children's social-emotional growth and development.

## **Developmental Screening and Assessment**

EOAC Head Start 0-5 uses research-based tools to screen for developmental concerns and track children's growth and development progress.

#### Screenings

- Developmental screenings completed within 45 days of a child's start date in the Early Head Start and Head Start programs utilizing the Ages and Stages (ASQ3) Questionnaire.
- Social-emotional screenings completed within 45 days of a child's start date in the Early Head Start and Head Start programs utilizing the Ages and Stages -Social-Emotional (ASQ-SE) Questionnaire. Screenings are completed based on the Texas Periodicity Schedule.

#### Referrals

If a screening demonstrates a need for referral, infants and toddlers are referred, with parental approval, to Klaras Children's Center Early Childhood Intervention (ECI) for further evaluation. With parental permission, three and four-yearold children are referred to the Local Education Agency for further evaluation.

#### **Developmental Assessment**

Assessment data is used to identify growth, set goals for individual children and their classrooms, plan staff development, and report progress to parents & funding sources. Data is also used to monitor progress toward our School Readiness Goals.




Assessment System: Children's Learning Institute (CLI) Engage Progress Monitoring

- Measures 15 different research-based measures in key developmental areas.


### **EOAC Early Head Start Developmental Assessment Outcomes**

#### Assessment System: Teaching Strategies GOLD®

- Aligns with the Texas early learning guidelines and the Head Start Early Learning Outcomes Framework.
- Uses teacher/family observations of children in the context of everyday experiences; multiple observations are documented on each child weekly, focusing on 23 research-based development and learning objectives grouped into six (6) areas of development: social-emotional, physical, language, cognitive, literacy, and mathematics.
- It uses a color-coded system to show the widely held expectations for children. These color bands appear for each objective to show what step we can expect children to be at for each age group.
- It allows teachers to create individual child profiles, identifying what each child knows and scaffolding his/her learning accordingly. Data are then reviewed and summarized at the checkpoints.

Pursuant to the Improving Head Start for School Readiness Act of 2007, Head Start grantees must make available to the public an annual report that discloses specific information. The EOAC Head Start five-year project period is July 1, 2019, through June 30, 2024. The annual budget period is May 1<sup>st</sup> through April 30<sup>th</sup>. The Head Start program operates August through June (10 months) and Early Head Start operates August through July (12 months) providing center based and home based program options.
