Carl Ritter presented the grades 3-5 test results for the first set of benchmarks before STAAR in May. The middle of the year benchmark testing has not been completed since this week is considered the mid-year point. Mr. Ritter stated that some grades are on pace to have good passing results and some are in need of remediation. Mr. Ritter stated that teachers are taking the results and planning for future instruction. The next benchmark testing will take place in February followed by the last benchmark testing in March or April.

BOARD MEMBER TRAINING HOURS AND REQUIREMENTS

Dorothy Marstaller presented the training hours and requirements to the Board. Ms. Marstaller stated that Stephanie Kucera with Region 12 is currently working to offer three trainings sessions throughout the year. Susan Copeland reminded the board members of the importance of training.

Ms. Marstaller stated that there has been a decline in attendance due to strep and other viral illnesses. The morale of the staff is good, and they continue to push forward.
